This is regarding Compliance Reports submitted by **Teegala Krishna Reddy Engineering College, Survey No. 8, RN Reddy Colony, Medbowli, Meerpet Post, Saroor Nagar, Hyderabad- 500097 Telangana** for the UG Engineering programs which were accredited by NBA in Tier-II for academic years 2017-18 to 2019-20 whose validity has expired on 30.06.2020.

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Teegala Krishna Reddy Engineering College, Survey No. 8, RN Reddy Colony, Medbowli, Meerpet Post, Saroor Nagar, Hyderabad- 500097 Telangana** as a whole. If such an instance comes to NBA's notice, this will be viewed seriously.
