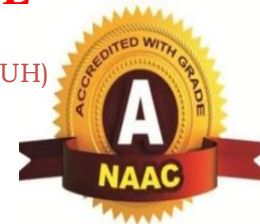

❖ Meetings: Meetings of the Finance Committee shall be held at least once every six months.

- ❖ Budget estimates relating to the grant received/receivable from funding agencies, income from fees, etc. and
- ❖ Audited accounts for the above

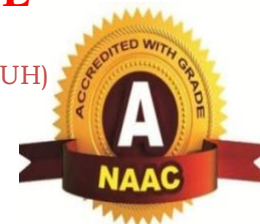
