Faculty members are allocated subjects based on their expertise and preferences. Course study materials, such as lecture notes, question banks, and lab manuals, are created by the faculty members, emphasizing outcome-based education and Bloom's Taxonomy. Students receive hard copies of the question bank and lab manual. Timetables for theory, tutorial, and practical classes are prepared in advance each semester according to the curriculum credits. Curriculum delivery follows proven approaches and adheres to academic schedules. Faculty members create lesson plans detailing the hourly method of course delivery for all subjects. The quality of course delivery is regularly monitored through student feedback, unit-wise syllabus coverage, and deviations from the lesson plan. Department heads and institutes review practical classes. Special classes are organized for any missed days or additional support needed by students. Value addition courses related to subjects provide hands-on experience, and special coaching is offered to slow learners. Additionally, all processes

are documented regularly.

All students must attend a counseling session when they start at the college before filling out certain forms. The college checks how well students are learning in two ways when classes begin. It looks at students' scores from their previous studies and also gives them a test. This helps identify students who might need extra help and those who are doing well. Teachers in each class also give feedback based on watching students and giving them small tests.

There are many different assignments and tests throughout the year, like homework, class assignments, seminars, quizzes, and more. These help the college understand how well students are learning. Teachers and committees regularly check on students' progress and talk to them to help them do better in their studies. There are also special sessions to encourage a positive attitude and a desire to do well. This whole process helps keep track of how students are doing and helps them improve.

At TKREC, the teaching approach revolves around making education student-centered. This method aims to change students from passive recipients to active participants, boosting their confidence and independence. In a student-centric class, it's recognized that students have different abilities to understand and learn. Unlike a teacher-centered class, where everyone is expected to learn the same way, here, the teacher helps each student learn at their own pace. This is done by involving students in class activities, allowing them to comprehend and grasp information based on their individual understanding.

At TKREC, we embrace ICT-enabled teaching alongside traditional classroom methods. All classrooms and labs are equipped with projectors, and the campus has a high-speed wifi connection. During the lockdown, teaching shifted entirely to an online mode. Faculty members utilized various ICT tools to enhance the quality of teaching and learning. Platforms like Google Meet or Zoom were used for tests and lectures, employing interactive methods such as animated PowerPoint presentations, video clips, and online resources from NPTEL, Coursera, and YouTube links.

TKREC has a clear and strong evaluation process regarding how often and in what way assessments are conducted. To maintain transparency in internal assessment, the assessment system is shared with students in advance. Continuous evaluation takes place for students enrolled in a course through various methods at both the college and university levels. This includes Unit Tests, Assignment submissions, Field visits/Field Work, and Seminars Presentation. Students' performance is regularly updated in the MIS portal for access by all stakeholders. Personal guidance is provided to students who perform poorly in assessments.

For students in their second or third year, delivering seminars on the subject is a requirement. Teachers assign topics for PowerPoint presentations to ensure transparency and robustness in internal assessment. The process involves an Internal Examination Committee, Question Paper Setting, Exam Conduct, Result posting in the MIS portal, and interactions with students about their
