# Item No: 4 Implementation of the Administrative Autonomy and Policies

The Governing Body confirmed the autonomy of administration in the college. The Governing Body approved the Examination Policies for Autonomy and made few suggestions regarding evaluation process.

#### Examination Policies for Autonomy

- 1. Following JNTUH system completely for 2020 joining batch.
- 2. Regulations will be as per JNTUH for 2020 joining batch.
- 3. Internal Evaluation 25%, External Evaluation 75%.

- 4. 2 sets of question paper from outside experts and 1 set from internal faculty ( will be used in need at moderation )
- 5. 50% Evaluation by Internal faculty and 50% Evaluation by outside evaluators.
- 6. Single evaluation system.
- 7. Recounting, Reevaluation and challenging evaluation system will be incorporated.

#### Item No: 5 Approval for appointment of Controller of Examination

The Governing body approved the appointment of Dr. K M V Madan Kumar Professor of Computer Science & Engineering as Controller of Examination for smooth conduction of examination processes in autonomy.

#### Item No: 6 Reduction of Intake and Introducing New Courses

The Governing Body approved the proposal for introduction of new courses from the coming academic year.

1. Approval towards applying 60 intakes in new emerging courses like AI & ML and Computer Science & Design.

### Item No: 7 Utilization and Allocation of Budget

The Principal presented the annual budget of the institution and the Governing Body discussed the requirements in the departments for UG & PG programs. The Governing Body observed that the headings in the presentation of the principal are broad and advised to include a report of three years Budget allotted to individual departments and maintain the records to support the utilization. However, the GB members approved the following Budget upon discussions:

#### **Additional Suggestions**

The Governing Body made few suggestions regarding faculty development, teaching-learning process, evaluation process and research funding and related activities.

- Apply for accreditation for the postgraduate programs (M.Tech. and M.B.A.), as it
  will help to achieve 50% of accreditation of total number of courses in an autonomous
  college.
- Encourage the faculty to improve their qualifications esp. by registering in Ph.D., as highly qualified faculty are also a matter of concern in Accreditation.
- Find out the possibilities of campus internships with reputed companies so that the students have the experience of working on real time projects.
- Try to generate funds for the college through collaborations.
- Student-centered teaching should be encouraged.
- Focus on enhancing employability and Communication skills of the students.
- Try to strengthen R and D Cell with more expenditure on research activities and encourage meritorious students and young innovators with incentives.

At the end of the meeting, The Principal requested permission from the BOG to fill the sanctioned 195 posts and the BOG granted permission to recruit the required new staff members of 28 to meet the required faculty strength and advised to recruit a few from the industry.
